Exhibition Rules

1. How to apply

Please fill out the application form and submit to the Show Management Office.

2. Application Deadline

Early bird : April 30 (Fri.) , 2021

Application: June 30 (Wed.), 2021

When the number of application of booths reach the number of planned, application will be closed before the deadline, June 30.

3. Contract

The contract would be concluded when the Show Management Office received the Exhibition Application.

4. How to pay the exhibition fee

After receiving the Exhibition Contract, the Show Management Office issues an invoice, and please make a payment as following designated bank account by the due date of payment.

Currency: JPY only

Bank: MUFG Bank, Ltd.

※All bank charges, including Japan bank fee, will be borne by the Applicant.

5. Terms of payment

All fees must be paid within the deadline, otherwise, the organizer has the right to cancel and/or reserve the contract until the exhibitor makes a full payment.

6. Cancellation of application for exhibition

Cancellation, as a rule, shall not be accepted after the submission of the Exhibition Application. However, it may be accepted if the Organizer considers it unavoidable.

Cancellation fee

Until June 30 (Wed.), 2021 50% of Exhibition fee

After July 1 (Thur.), 2021 100% of Exhibition fee

Cancellation Date would be the date when the Show Management Office received a written document to inform the cancellation from the Applicant.

Upon receipt of cancellation, the cancellation fee will be charged to the applicant based on the Exhibition Rules.

Please note that the exhibition contract would be expired and cancellation fee would be occurred if the organizer cannot confirm the preparation of the booth by September 14 (Tue.), 2021.

If exhibitor reduce the number of booth after application, early bird is not applicable and cancellation charge will be calculated by normal fee.

7. VISA Information

Foreign citizens may be required to obtain a visa in order to enter Japan.

The visa application process is often very complicated and time-consuming so we strongly recommend that you begin this procedure as soon as you have made your decision to participate in the exhibition.

The regulations and time required to receive a Japanese visa differ by country.

8. Exhibit regulation

Please note that organizer might refuse to exhibit if the products and services are not suitable for the exhibition.

9. Booth allocation

Organizer will decide booth allocation, considering the exhibit, booth size, booth configuration.

As a general rule, exhibitor cannot book the separate space, for example both side of the aisle.

To allocate booth space smoothly, please make a decision for booth size and configuration by the application deadline and submit application form to the Show Management Office.

Organizer would like to make maximum efforts for booth allocation requested from exhibitors, however, please note that it may be unable to satisfy applicant's request.

10. Control and Protection of exhibits

Regarding to management of exhibits in the exhibition hall, organizer shall do its best to take charge of control and protection, however, it shall not be liable for any disaster, theft, loss, damage, and other accident. Organizer recommends to purchase insurance for exhibits.

11. Change and Cancellation of the Exhibition

Due to natural disaster or any reason, organizer may change the exhibition period or cancel the exhibition. Organizer will not make a compensation for any damage occurred for the reasons above. However, it may make restitution of a part or full of exhibition fee, if the exhibition is cancelled beforehand.

12. Subsidiary rules and Change of regulations

Regarding any regulations of the rules and operation of exhibition, organizer shall announce that, through "Exhibitor Manual" or any documents. Due to unavoidable reasons, organizer may change the exhibition period or partly change the rules.

13. Privacy Policy

Personal information would be used for various information of the Exhibition from Organizer.

Please also be forewarned that personal information might be provided to cooperating companies or delivery firms who agreed non-disclosure contract.
